Section I Pursuant to Article 7, Section 110 4.(a) of the New York State Agriculture and Markets Law, the Town of Belmont hereby imposes an additional local license fee of two dollars and fifty cents (\$2.50) above the statutory license fee of each dog license issued in the Town of Belmont

Section II. Such additional fees will be used for the control of dogs and enforcement of Article 7.

Section III. If any clause, sentence, paragraph, section or part of this local law shall be adjudged by any court of competent jurisdiction to be illegal or void then such clause, sentence, paragraph, section or part shall be deemed severed from this local law and the remaining provisions shall remain in full force and effect and its provisions strictly enforced.

Section IV. This local law shall take effect immediately upon its passage by the Town Board of the Town of Belmont and its proper filing as required by law.
