Section 1. Authority

Section 27 of the Town Law of the State of New York provides that the Town Board may increase the annual salary of an elected official for not more than one (1) fiscal year in excess of the amount specified in the notice of hearing on the preliminary budget by a local law adopted pursuant to the Municipal Home Rule Law.

Section 2. History

The notice of hearing on the preliminary budget of the Town of Belmont for calendar year 1992 fixed the salary of the Highway Superintendent for the year 1992 at \$6,500.

Section 3. Salary Increase

The annual salary of the Highway Superintendent of the Town of Belmont for the fiscal year 1992 which is the calendar year 1992 is hereby increased to \$25,000.

Section 4.

This local law shall become effective immediately upon filing with the Department of State. This local law has been enacted prior to the commencement of the term of office of the Superintendent of Highways. That term commences January 1, 1992.
